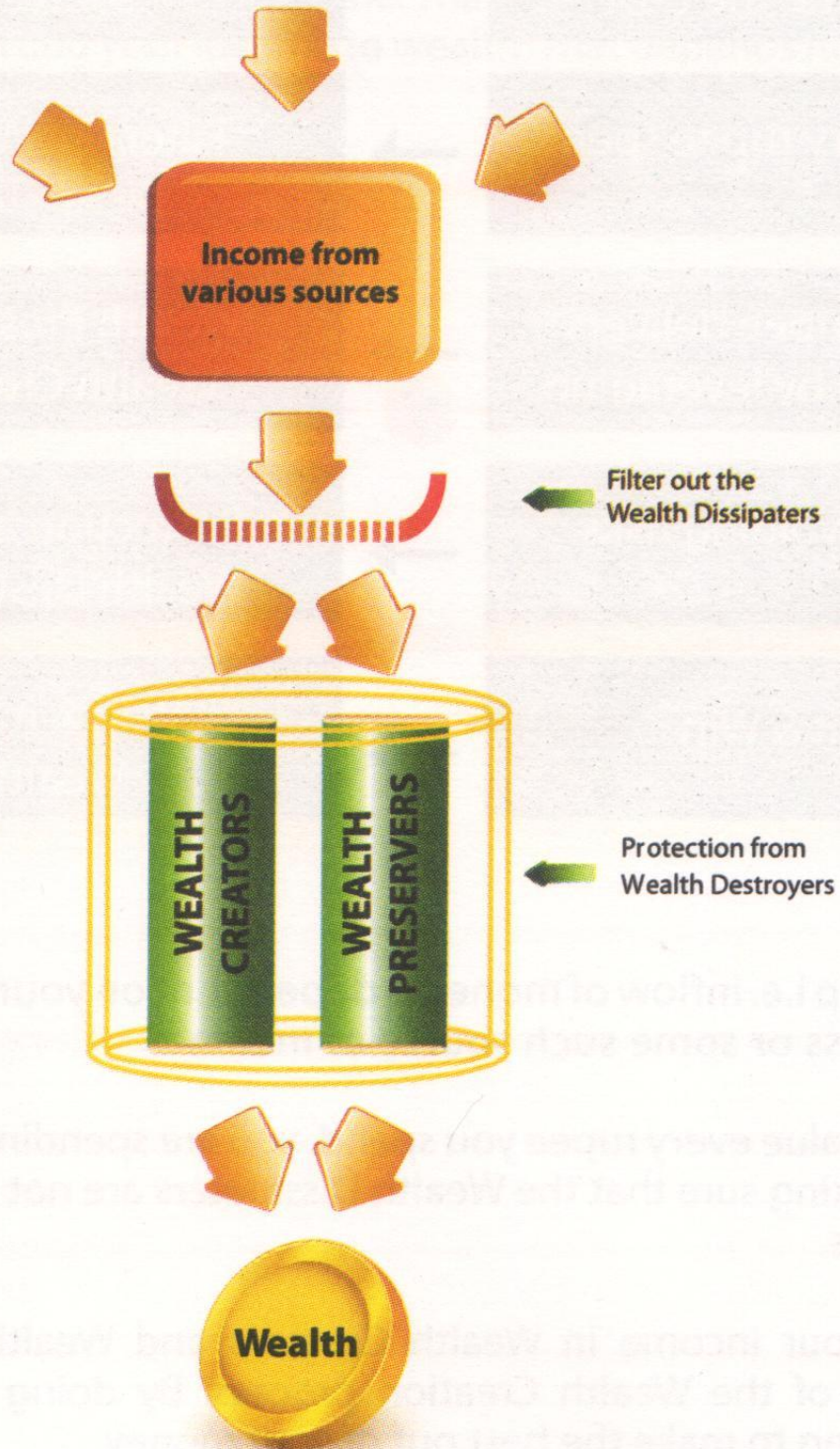
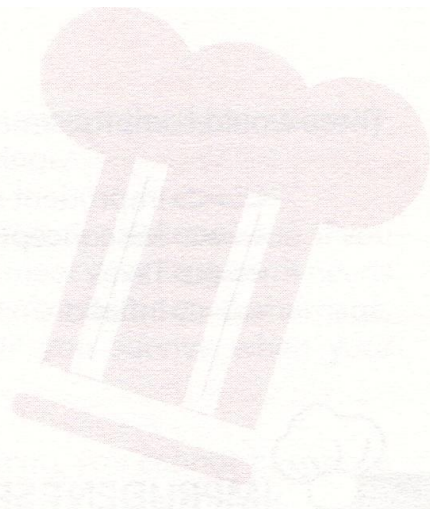


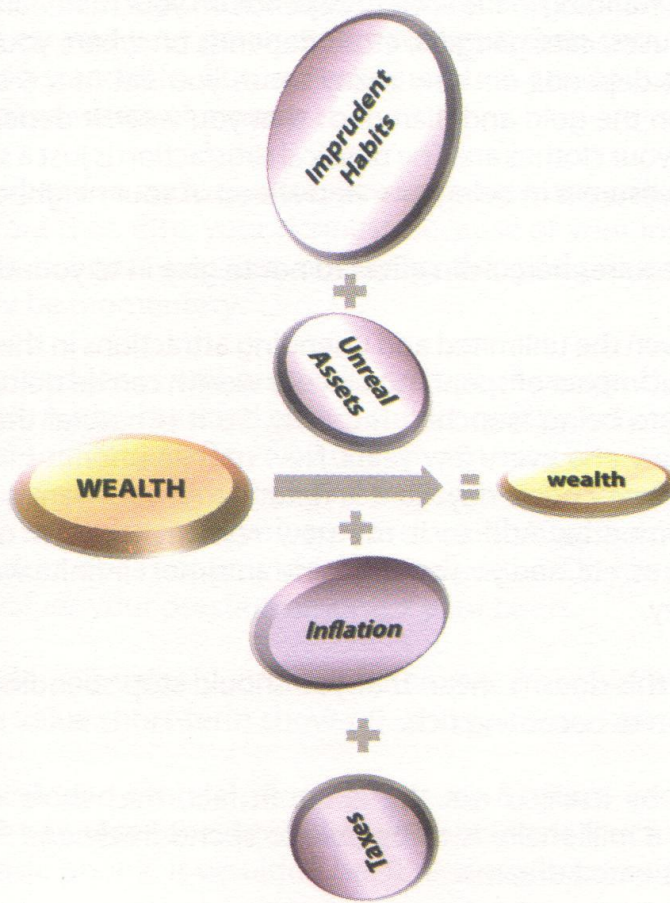

# Wealth Dissipaters

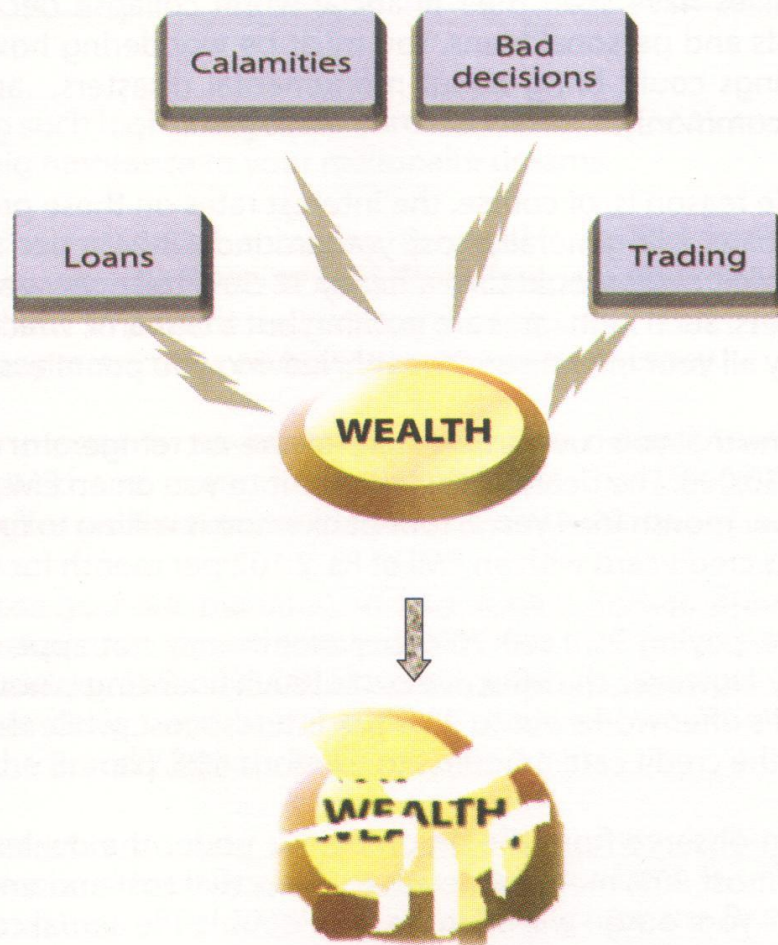


Certain things will slowly but surely eat into your income and/or wealth. Therefore, as time goes by, you will experience a gradual reduction in your wealth.



# Wealth Destroyers

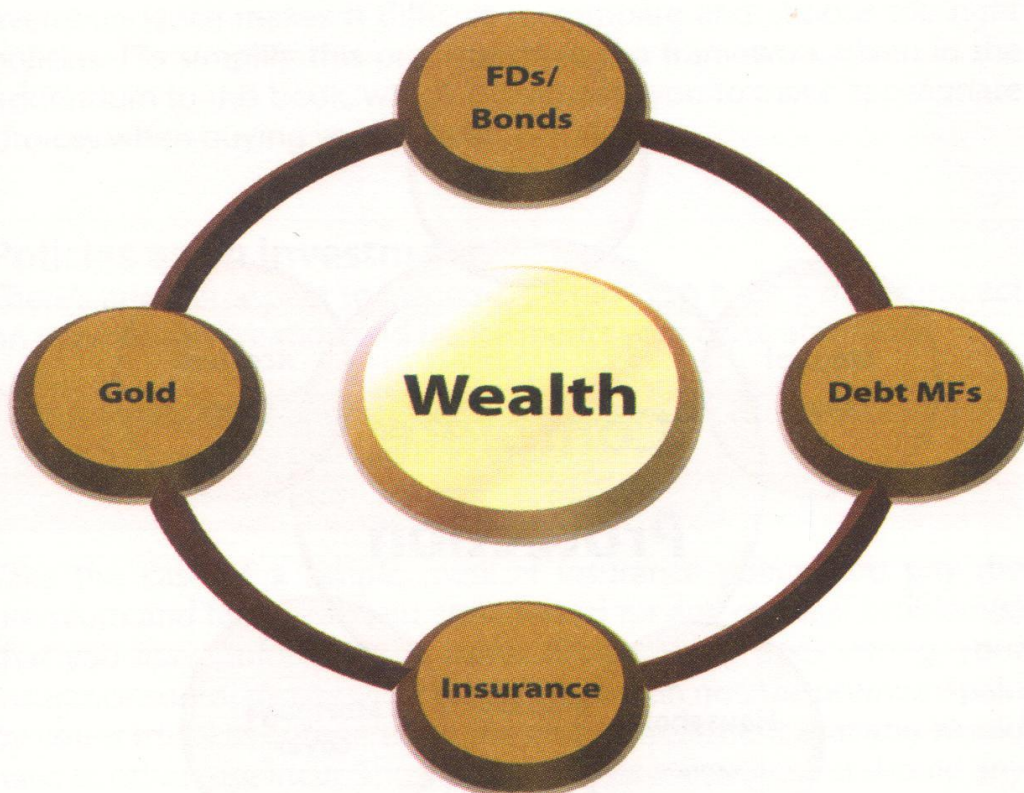
